**Royal Commission Update - 12th Edition** 

**ACSA CEO APPEARS AT ROYAL COMMISSION** 



#### Dear Debra,

At the conclusion of the second week of the first hearing of the Royal Commission into Aged Care Quality and Safety ('the Aged Care Royal Commission' - ACRC), the focus of questioning has been on the way the system currently functions - hearing from consumers, provider peak bodies and Commonwealth agencies. The hearing has included testimony on:

- Availability of Home Care Packages (HCPs), expenditure on residential aged care and future funding needs;
- Personal care workers, improvements to education, registration system, overworked staff, pay and conditions and future workforce needs;
- Rigidity of the current regulatory system to allow for the concept of dignity of risk;
- Medication management;
- Anticipated changes to flow from the Aged Care Quality Standards coming into effect on 1 July;
- Issues around the interface and access to health services for aged care consumers;
- The need for a more person centred aged care system that fosters innovation and better meets the needs of the individual;
- Staffing ratios; and
- The use of physical and chemical restraint.

The line of questioning from the two presiding Commissioners may provide some insight into how they are approaching their examination of the aged care system. Themes included:

- Staffing and expectations around staffing, community confidence in providers, and appropriate levels of staffing and skills mix;
- Aged care workforce and training requirements;

- Access to and funding for palliative care;
- Innovative models of aged care; and
- Person centred care.

The consumers who appeared yesterday spoke about access to care and services. Appearing on Tuesday, ACSA CEO, Pat Sparrow, was questioned about:

- The meaning of quality and safety;
- Funding constraints;
- Increasing frailty of those entering residential aged care;
- Dignity of risk vs regulation;
- The right of aged care consumers to access GP and other health services;
- Clinical care;
- The new Aged Care Quality and Safety Commission and whether it will improve quality;
- CCTV;
- Access to HCPs;
- My Aged Care;
- Staffing ratios;
- Palliative care; and
- Innovative models of care.

#### Overview of the ACRC for the week of 18 February

#### What's next for the ACRC

The ACRC will conduct hearings in all capital cities and a number of regional locations from March to December this year. The locations of each hearing will be announced progressively throughout the year as arrangements are finalised. The ACRC will now turn to a more detailed examination of its Terms of Reference.

Open to the public, these forums will provide an opportunity to hear about the work of the ACRC and to offer ideas on the challenges, strengths and opportunities to improve aged care in Australia. SAFE in Oz aim to give workshop participants an insight into the headspace of a person who participates in self-destructive behaviour/s in order to better understand their 'real' world and life experiences. The training encapsulates individuals needs throughout their lifespan and is flexible and responsive to the workshop participants.

#### Day 1 - What is it all about?

What is self-destructive behaviour? How do we know it is a self-destructive behaviour? Why do individuals do it? How does it start?

What are the triggers for self-destructive behaviour and why does it continue to happen?

#### Day 2 - Our response to Self-Destructive behaviour/s.

Meeting the needs of someone who with self-destructive behaviour/s. Hospitalisation and associated problems. Treatment environments and points of intervention. Boundaries, support plans and essentials for behavioural change. Meeting the needs and supporting the worker. Introduction to 'Facilitating the SAFE in Oz Consumer Recovery Program' a three day facilitator training workshop.

Throughout the workshop, SAFE in Oz will encourage participants to employ strength based practice, in collaboration with their clients, as a means to discovering a myriad of healthier alternative behaviours to use in response to their inner trauma.

As this behaviour does not impact solely on the physical aspect of an individual's life, the workshop also links self-destructive behaviour to its impact on the, emotional, spiritual and social aspects of life and explore the related long term effects.

The workshop will discuss the connection of this behaviour and suicide, BPD [Borderline Personality Disorder], mental illness, sexual assault and domestic violence, offering an insight of the link with adolescence.

The presentation mode for the workshop is both interactive and activity based and includes 'real' case studies, PowerPoint presentation, DVD and an interactive game.

Each workshop participant is provided with a SAFE in Oz presentation folder. The folder includes a workbook for each day which contains a copy of the PowerPoint presentation, activity pages and additional subject related reference material.

The activity sheets include strategies and tools for use with clients, while the reference material acts to enhance understanding, give insight into related topics and support you in your work practice.

#### The topics are:

**DRIVING AND DEMENTIA:** This online education and support session runs for approximately 45 minutes and provides information about the effects of dementia on driving. It is specifically designed for people living with dementia and their carer. Getting-around options for non drivers are also discussed. This is ideally suited to those that have received a diagnosis of dementia and drive or are caring for someone diagnosed with dementia who drives.

**RECENTLY DIAGNOSED WITH DEMENTIA:** This online education and support session runs for approximately 60 minutes and aims to provide information about dementia and support options to people living with early stage dementia, and their care partners.

**DIFFICULT CONVERSATIONS:** This online education and support session runs for approximately 45 minutes and explores topics that people living with dementia, their care partners, family and friends can find hard to talk about. This session also considers factors that make a conversation difficult and provides strategies that enable these tough conversations to occur.

#### **NEW \$250 TRAVEL CARD FOR NORTHERN TABLELANDS SENIORS**

Travel is getting more expensive for seniors living in our region, which is why I'm excited to announce the new Regional Seniors Transport Card.

The Regional Seniors Transport Card offers an annual \$250 discount on fuel and travel costs over the next two years, making it easier to get to the shops, the doctor or just to visit family and friends.

People in the big cities can jump on subsidised public transport whenever they like – I think it's only fair you get something as well.

One of my big priorities as your local MP in the State Parliament is making sure I take care of our seniors and this is another way I can help to say thank you to you for the lifetime of work you've given and the contribution you make to our community.

To be eligible for the card, you need to be either an aged pensioner or a

Commonwealth Senior Health Card holder who lives in country NSW.

The new program will be rolled out from January 2020 and can be used for petrol and taxis from participating providers in rural and regional NSW, or to pay for the existing concession fares on pre-booked NSW TrainLink trains and coaches.
