A MESSAGE FROM NCOSS CEO

Dear All,

NCOSS welcomes the announcement that there will be an increase in indexation to 2% and congratulate Minister Ward for backing us in this ask. Thank you to all of those in the sector who have spoken out to highlight the negative impacts that the lower indexation rate will have on our capacity to provide services to those most in need.

There is still progress to be made. Securing an indexation rate of 3% will assist the sector to fund the pay increase and meet the growing demands on our services. Given the recent NSW Government announcement of \$1.2 billion for 2018-19, NCOSS will continue to advocate for a further increase.

We were also pleased to see announcements regarding the TEI recommissioning process and applaud the intention to transition to 5 year contracts. We will be working closely with the Department of Communities and Justice to ensure that the sector is well-supported through the process of negotiating and finalising contracts. And we will work with our colleagues to ensure that similar steps are taken to support other organisations whose funding agreements are due for renegotiation, including those organisations funded under Specialist Homelessness Service agreements.

This week is the annual Anti-Poverty Week. NSW is an affluent state, and yet 1 in 6 children in our State live in poverty. This week we're shining a light on the disadvantage experienced across the State, particularly in our regional communities. There is a lot happening, so make sure you get involved in the events and advocacy efforts using the APW resources!

Don't forget that we're hosting the 'Putting Regional Needs on the Map' event at NSW Parliament House on 24 October. We are bringing together a broad coalition of regional and cross-sector voices to provide a platform to discuss the concerns and challenges faced by their communities. There is still time to register!

The <u>Australian Energy Regulator</u> has taken action to assist vulnerable customers experiencing payment difficulties by introducing an enforceable <u>Customer Hardship Policy Guideline</u>. Energy retailers have important responsibilities in helping vulnerable customers. The Guideline requires energy retailers to provide consistent minimum standards of assistance, ensure hardship programs are easily accessible and put processes in place to identify customers who may need help. 



Royal Commission Update - 29th Edition

Dear Debra,

The Royal Commission was in session this week in Melbourne, enquiring into the aged care workforce.

Workforce issues have been a significant challenge across the industry for many years, and are set to worsen as the supply of qualified aged care workers outstrips demand.

At a high level, witnesses identified that there are inadequate numbers of staff, they are inadequately trained, and they are inadequately remunerated. Providers face significant challenges in attracting, training and retaining staff.

All witnesses agreed that the current framework is not sustainable and urgent reform is needed.

Key themes covered this week were:

- The centrality of the workers to care outcomes.
 - Witnesses agreed that staff are the key input into producing quality care and quality of life for people receiving aged care services, either in their own home or in a residential care facility.
 - As ACSA's Darren Mathewson put it during his testimony on Wednesday;
 'staff is the most important resource in delivering quality care."
- The need for a lift in remuneration across the aged care workforce, particularly for Personal Care Workers (PCWs).
 - o No witnesses contested that the aged care workforce is underpaid.
 - There was general support for the recommendation of the Pollaer's Report that there needs to be a 15% increase to wages to help providers attract workers.



- The failure of current aged care qualifications, particularly the Certificate III in individualised support, to produce sufficiently skilled workers.
 - The current curriculum from which aged care workers are trained does not sufficiently prepare them for the tasks they must perform or the environment they must work in when they graduate and enter the workforce.
 - The lack of sufficiently skilled staff is preventing providers from being able to deliver high quality care to their clients and residents.
- The inability of the current accreditation and compliance scheme to ensure all residential aged care providers meet the relevant standards in relation to ensuring an appropriate level of qualified staff.
 - As illustrated by the Menarock Life case study, the Aged Care Quality and Safety Commission, which provides little guidance to its assessors on what appropriate levels of staffing would look like for different acuity cohorts, is failing to ensure facilities have adequate staff levels in place.
 - The lack of sufficiently skilled staff is preventing providers from being able to deliver high quality care to their clients and residents.
- Aged care workers report feeling undervalued, time-poor and unsafe.
 - Workers report that their poor remuneration sends a signal that their work is undervalued.
 - They also report high levels of stress, feeling like they are rushed to complete the tasks they are assigned each shift and lacking the time to provide proper attention, warmth and care to their clients.
 - Instances of abuse and unsafe work environments, particularly for home care workers, were also highlighted.
 - These factors together contribute to the difficulty providers face in attracting and retaining workers that have the skill and temperament to deliver quality care.
- That the Aged Care Funding Instrument (ACFI) is not fit for purposes, and the need for a funding mechanism that classifies and responds to the acuity of residents.
 - Most witnesses voiced support for the case-mix approach of the Australian National Aged Care Classification (AN-ACC) developed at the University of Wollongong as part of the Resource Utilisation and Classification Study (RUCS).



- The case-mix approach is designed to ensure that residents with the same care needs receive the same funding.
- It is also designed to decrease the amount of paperwork and compliance that often ties up the time of Registered Nurses, who end up 'nursing the desk' rather than helping deliver and oversee clinical care in facilities.
- The lack of a mechanism to determine appropriate staffing levels, from which more comprehensive quality standards around staffing could flow.
 - Witnesses agreed that apart from the RUCS and a similar piece of work done in collaboration between the ANMF and Flinders University, there are no solid methodologies available for providers to determine the appropriate levels of staffing for their resident profile.
 - If there is a move from ACFI to a case-mix approach to funding, witnesses agreed it may be possible to enshrine some degree of staffing baselines in the quality standards.
- A Personal Care Worker registration scheme could help improve safety and quality outcomes for older Australians receiving aged care recipients.
 - The Commission heard evidence that a registration scheme for workers similar to other health professionals such as nurses could help safeguard vulnerable residents from workers who are unsuitable for the trusted position, they occupy in aged care facilities and people's homes.
 - The Commission heard that the Aged Care Quality and Safety Commission
 has no power to keep track or to take action against Personal Care
 Workers who have had allegations of misconduct made against them, as
 heard in the Japara case study.
 - The Secretary of the Department of Health testified that they aim to bring legislation to enact a registration scheme in the next twelve months.
- The crucial role of good governance and leadership in aged care providers to responding to workforce challenges.
 - The Commission heard from a panel of leading aged care providers who testified that although the funding constraints affect all providers, good governance arrangements and strong executive leadership allow providers to deliver excellent care to their clients and a positive professional experience for their workforce.
 - As Benetas CEO Sandra Hills puts it: "It all starts from the culture of the organisation right from the very top, the board of directors, right through to



the executive... it's not just about funding. We all get the same amount of funding."

- The lack of engagement or leadership from the Commonwealth in responding to the need for reform.
 - Counsel Assisting stated that the Commonwealth has been "missing in action" when it comes to providing engagement or leadership on aged care workforce issues.
 - As the majority funder and a key stakeholder, witnesses testified that Commonwealth leadership is required when it comes to increasing wages, improving training outcomes and solving some of the skills-mix issues in residential aged care.
 - John Pollaers, author of the Workforce Strategy, expressed disappointment in the lack of urgency with which the government has approached the strategic actions listed in his report.

The Royal Commission will next meet in Mudgee from 4 - 6 November to tackle the provision of care in regional areas. That hearing will be followed the next week by a hearing in Hobart into the operation of selected Approved Providers.



One more week until the Royal Commission Interim Report

The Royal Commission will deliver its interim report next Thursday, 31 October to the Governor-General in Canberra.

ACSA anticipates the report will focus on the late Commissioner Tracey and Commissioner Briggs' overall impressions about the aged care system and will provide some detailed analysis of topics covered from the commencement of the Commission's hearings until August this year. It will not make any recommendations, nor will it cover any of the evidence from the Brisbane hearing onward, including regulatory responses or the workforce issues aired during last week's hearings.

Despite not covering workforce or regulatory issues in-depth, we nevertheless expect the report to reflect on issues around the quality of clinical care provided across the industry,



the perceived inadequacies of consumer safeguards, and structural concerns identified within the present system, including issues of system access.

The Royal Commission has been extended for six months and will continue to run public hearings and further deliberations ahead of delivering its final report roughly this time next year.

ACSA will be attending a briefing on the report next Thursday. We will issue a special member update as soon as practical after the briefing (we are hearing it is a multi-volume and very large report!) with information around the Commission's views and findings to date.

To further support our members in understanding the Commission's findings we have scheduled the ACSA's Leadership, Quality & Transformation Symposiums to commence the week following the release of the interim report. This will be the first opportunity to unpack and understand where the Commission might be heading and prepare for the changes that will inevitably come. If you have not done so already, please <u>register now</u> for this key event.

It's imperative that the sector and the Commission in its next phase start to focus on the solutions to the many and varied issues that have been discussed. The structure and financing (both Government and individuals with means) are key if we want to see any real changes. ACSA will continue in its effective advocacy on the issues and solutions.

Fair Work Commission review of SCHDS Award 2010

ACSA Employee Relations is representing members in the Fair Work Commission (in the four yearly reviews of the Aged Care Award 2010 and the Social, Community, Home Care and Disability Services Industry (SCHDS) Award 2010. The Full Bench has determined that instead of applying a 10% increase on 1 December and the remaining 15% from 1 July 2020, the entire 25% be applied from 1 July 2020 – for both awards. This will assist employers in meeting their current FY budget targets and allow time for them to plan their casual workforce and factor the 25% into their 2020-2021 budgets. Read more


Good news member story - Elderly artists paint and raise over \$30,000 for orphans of Fiji

ACSA is delighted to announce to members that its Employee Relations (ER) support service has been strengthened. The ER team's depth and reach have been expanded across the country. With Anna-Maria Wade as the ER Manager and based in NSW,



members can now get further assistance from the ACSA Employee Relations Advisors Florentina Min and Adele Rizkallah, based in Western Australia and New South Wales respectively.

ACSA ER team fields enquiries from providers all over the country and provides an ER support service exclusively for members. This service assists with tackling issues which arise during the employment relationship - from day to day award and agreement interpretations, through to managing more complex performance management and disciplinary issues. The team aims to keep members up to date with current practice, changes to the Australian employment relations framework and industrial tribunal decisions which may impact on the operations of their businesses.

This ER support service is included in ACSA membership and the ER team works with members and assist them in strengthening their internal HR capacity and capability. Fair Work Ombudsman's tough approach to underpayment issues

Underpayment of staff is a serious issue and one that continues to garner attention. In our last ER newsletter, we published a short article on the importance of paying staff correctly.



Incorrect payments can have a significant impact on productivity and lead to fines and reputational damage for organisations.

You may recall earlier this year, the Fair Work Ombudsman (the FWO), Sandra Parker, warned employers to "get their house in order", stating "It's on us to send a strong message of deterrence to would-be lawbreakers". The FWO has followed through with this message and their 2018-2019 Annual Report reveals a significant increase in recovered wages. During the 2018-2019 financial year, Fair Work Inspectors recovered more than \$40 million for 18,000 underpaid employees, the highest total recoveries figure in the regulator's history.

Employers' obligations with respect to parents returning to work from Parental Leave?

Employees returning to work from parental leave have a statutory right to return to their preparental leave position and the right to request flexible working arrangements, including working part-time, changing starting and finishing times or working from home. With regards to flexible working arrangements, an employer is not obliged to automatically approve the request.

Pre-parental leave position

The pre-parental leave position is the job the employee held before any changes were made to accommodate their pregnancy, such as moving to a safe job or reduced hours of work. An employee is entitled to come back to their pre-parental leave position even if another person has been covering for them.

If there are any changes to their pre-parental leave position, an employer must consult with them as per consultation provisions of an award or enterprise agreement.

Flexible Working Arrangements (FWA)

When a request for a flexible working arrangement is made, employers should balance the need for employees to care for their children against legitimate business needs.

Claim for unfair dismissal for reasons of serious misconduct by home care worker dismissed by the Fair Work Commission

Background

The applicant, Ms Hanna, commenced work with the employer, Home Care Assistance, in about February 2018 and was employed as a casual Home Care employee.

On 4 December 2018, the employer sent the applicant two emails which contained warnings about particular aspects of the applicant's conduct at work. In these warning emails, the employer raised concerns about several matters including the applicant taking her daughter to the workplace, leaving work earlier than her rostered finish time and not maintaining client privacy. The applicant received further warnings in January and February.

In February 2019, the applicant commenced to make applications for alternative employment and unsuccessfully sought a reference from the employer. On 25 February 2019, the applicant went to the employer's office after completing a job with a client and again, asked for a reference. The details of exactly what had transpired at the office were not clear, however, it was understood that the applicant left the office in a highly agitated state whilst making threatening statements directed at other staff members. A short time after the applicant left the employer's office, the employer sent an email message to the applicant dismissing her.
